

Grand Knight's Report by Kyle Hubbard



Greetings Worthy Brothers!

The month of May is the month of Mary, where Catholics offer up an especially fervent and loving homage of prayer and veneration to the Blessed Virgin. One of the defining characteristics of the Knights of Columbus is its members' deep devotion to Mary. Every Knight receives

a rosary when he joins the Order and is encouraged to turn to Mary as his own Mother, so that she may lead him closer to her Son.

As we move away from the social restrictions imposed by the pandemic toward a new normal, the Knights of Columbus are transitioning from the Leave No Neighbor Behind Program (LNNB), with programs aimed at supporting Brother Knights, the Parish, and the Community; feeding the hungry; and organizing blood drives, to the COVID Recovery Program (CRP). The CRP will focus on resuming operations in a way that inspires members and parishioners to become reinvolved with Church and community activities. The CRP has three key elements: parish support, interactions between state and local councils, and fraternal engagement. We will be looking to implement aspects of the CRP as details become available.

The 123rd Annual Maryland State Convention was held May 1st. The Council had two resolutions approved: one recognizing our 100th anniversary, the other recognizing 50 years of service for Monsignor Mike Mellone. Patuxent Council was also the recipient of mul-

tiple awards, recognizing the impact of our Faith in Action programming throughout the past Fraternal Year. For submitting a report in each of the four Faith in Action areas (Community, Life, Family, and Faith) for each quarter, we were presented the Faith in Action Award. It should be noted that Patuxent Council submitted 28 reports, tied for most in the state. The State Council also rates programs and bestows a General Excellence Award to councils earning the most points in each Faith in Action programming area. Patuxent Council received three General Excellence Awards, including 1st in Community, 3rd in Faith, and 3rd in Life. We also came in 3rd place for the Program Director's Award, given to councils earning the most points over all Faith in Action programming. Finally, Patuxent Council was honored with a Supreme Council Service Award for the highest-rated single program in a Faith in Action programming area for the SHARE program under the Community category. This is an exceptional honor and puts us in the running for an international award conferred by the Supreme Council. We were also nominated for this award in the Life category. Congratulations and thank you to all Brother Knights! Your contributions to our service programs have been, and continue to be, exceptional. You, and your families, have demonstrated your commitment to the Parish and the community by putting your faith into action.

Consider our fraternal year penultimate Lecturer observation as your Insurance Agent Report.

Looking for qualities of a great membership recruiter? Consider the traits of any highly successful salesperson, *especially* a Knights of Columbus insurance field agent.

Becoming a Knight as well as buying our life insurance is a commitment of *time*, *money* and *effort*. We can choose to involve ourselves in any number of service activities outside of and instead of our Order, *if we choose to do so at all*. We probably can also buy life insurance *cheaper* elsewhere. All regular and insurance member prospects alike must know that they receive and provide value for their efforts.

Convincing prospects of their fraternal benefits and membership *values* are key. Field agents work to have members contribute to their family's futures; so too does a recruiter convince a man to make lifelong contributions of their efforts to the Order. Only then will men contribute their valuable time and treasure as Knights to help others, especially their families and their fellow Knights.

Field agents and council recruiters fail if their only concerns are their income or making quota. Truly successful salespeople sell quality products using relationship selling. Build rapport and trust to discover and understand a prospect's *needs*. Never gain that trust – or far worse, lose it - you lose the prospect.

Great sales and recruiting are *never* one-time affairs. Agents meet periodically with our Knights and their families to meet their changing needs, especially when providing benefits support. They also offer new products to meet new and potential challenges. These efforts sell more products over time, lead to word-of-mouth referrals to other knights and their families, and make our insurance program stronger.

So too should a membership recruiter reach out to that new Knight, encourage their participation in council activities as well as assist in times of need. Word of mouth from active new members in turn make them our best recruiters. This is the sure method to make council membership stronger.

Now go out there and start relationship selling. Tempus fugit. Memento mori. Vivat Jesus!

A big thank you to everyone who came out to assist with our May SHARE Distribution on Saturday, May 22nd. We had another very large distribution this month, with a total estimated weight of 5,765 pounds. This was driven by LARS ordering more than twice the number of Value Packs it typically orders for a large scale food distribution which was held later in the day, as well as our receipt of an additional 100 food boxes from the SHARE Warehouse courtesy of a substantial donation to the SHARE Program. These extra food boxes were split between our regular clients, the Pallotti and Sacred Heart Convents, LARS, Elizabeth House, and the residents of Selborne House on Main Street.

Thank you to all the volunteers who came out this month. We are also grateful for the ongoing support of the City of Laurel, which again loaned us a box truck and personnel for the morning to transport our entire order from the SHARE Warehouse in Landover back to the Keesler Center.

Warehouse volunteers should report to the Keesler Center by 7:25 a.m. for a 7:30 a.m. departure. **All other volunteers, please arrive to the Keesler Center by 8:45 a.m.** Over the last several months, the Warehouse team has been returning to the Keesler Center as early as 8:40 a.m. With the Saturday morning Mass no longer in the Keesler Center, we are able to get started right away and request your presence 15 minutes sooner than in the past so we can pray, make announcements, and start offloading the food.

Mother's Day Breakfast Report

Patuxent Council's Mother's Day Brunch drive through successfully supported the parish mothers with a to-go breakfast and potted marigold distribution after the 9:00am and 10:30am Masses. \$193.62 was netted for the morning activity from 8am through 12pm.

We served 16 sausage/bacon/onion/cheese frittatas, 9 spinach/mushroom/cheese frittatas, 3 cheese frittatas, 11 cinnamon roll boxes, 30 crumb cakes (double portions) and 15 fruit cups. Simplicity was the mantra. Orders were quickly filled to waiting cars as they arrived. Food preparation was done by 10am. The majority of sales were via PayPal. Only several drive up orders.

We used the Keesler center kitchen. Moved the warmer to the front lobby. Had three tables set up. One for the coordinator. Two for food distribution. Overall activity flow was very relaxed and efficient. Lots of social time.

Recommendations include: to improve: A banner(s) of some sort advertising the event. Possibly moving the sales to the Breen room - better when the Church smells the food preparation. Keesler Center kitchen is better for food preparation - especially the convection oven, warmer, refrigeration and storage.
